### Professional Indemnity Insurance Conference

We have completed the arrangements for this year's conference to be held at The Queen's College, Oxford, 26th – 28th of August. This is the Professional Indemnity event of the year. It is an opportunity to learn more about important issues facing the market, to meet others in the business and to debate some of the major issues. The fee for the 2-day conference is £1,095 + VAT, including accommodation, punting on the Cherwell and excellent catering.

### Liability Insurance Conference
